If the local grid operator does not receive a valid registration for grid use from a supplier selected by the customer and if the customer continues to withdraw low-voltage energy supply from the energy supply network after termination of the statutory replacement supply, an electricity supply contract (replacement follow-up supply) is concluded between the customer and OUTLET CITY AG through conclusive behavior. Notice period for substitute supply 1 day, notice period for basic supply 2 weeks.
